#### Payments to Kuwait in KWD



This document contains Purpose of Payment (PoP) codes for KWD payments to Kuwait. A purpose code should only be used for KWD payments to Kuwait and is not needed for payments in other currencies.

The code must be placed in the first line of the *details of payment | message to the beneficiary* field. Failing to provide the purpose code may lead to a delay or rejection of the payment.
