Furthermore, the Customer acknowledges that it is solely responsible for informing the Administrator and/or Supervisor of any amendments to or termination of the Agreement.

With reference to Clause 5 in the General Terms and Conditions for Trade Finance Global, the Customer hereby appoints the above person by way of a power of attorney as Administrator and/or Supervisor of Trade Finance Global.

**The Customer hereby authorises the above person to represent the Customer in and in relation to Trade Finance Global in the capacity of:**

☐ Administrator (an Administrator represents the Customer generally in administrative matters relating to Trade Finance Global, has the right to appoint persons as Users and remove persons from the list of Users in Trade Finance Global and, to the extent allowed by the Bank, to authorise Users to access information relating to Accessible Trade Finance Services)

☐ Supervisor (a Supervisor is authorised to grant and revoke authority in relation to existing Users and is authorised to remove persons from the list of Users in Trade Finance Global but may not add a person to that list. A Supervisor may authorise a User to be a Supervisor)

The authority of a Supervisor may be exercised by that Supervisor alone unless the checkbox for "Four-Eye Control" has been marked, upon which the authority may only be exercised by the Supervisor together with another Supervisor.

☐ "Four-Eye Control"

Irrespective of whether the authority to appoint a User is given to a Supervisor personally or jointly (i.e. with "Four-Eye Control"), such Supervisor is entitled to act alone in relation to removing a person from the list of Users in Trade Finance Global or revoking granted authority to make Trade Finance Transactions.
