## **Open positions in each Career area**

### **Customer Service:**

In customer service roles, you will have a front seat for learning the bank's ways of acting. You will be handing personal, tailored and inclusive advisory to a new generation of customers. Join us and help make tomorrow a little better than today - one piece of advice at a time.

In customer service, you will be learning extremely useful communication and sales skills. Don't worry about previous experience, you will succeed with a passion for helping customers and a positive mindset.

All positions in Customer Service require fluent Finnish language skill.

Customer service roles have the most open positions. Our centralized Customer Service units are located in Helsinki, Turku, Tampere, Oulu, and Vaasa. You are also welcome to apply to our branches in Helsinki, Espoo, Vantaa, Porvoo, Kotka, Kouvola, Lappeenranta, Lohja / Nummela, Hämeenlinna, Hyvinkää, Lahti, Mariehamn, Pori, Turku, Vaasa, Savonlinna, Jyväskylä, Kuopio, Varkaus, Iisalmi, Oulu, Rovaniemi, and Tampere.

**Administration / Back office / Support**

In administration, back office and support, you can work in various tasks supporting the business and their needs.
